Key issues that the guidelines attempt to evaluate are: 1) Segregation of duties and functions, 2) Oversight and control by council, 3) Accurate and timely financial reporting, for internal and external purposes and 4) Safeguarding of assets.

### Church Financial Review Guidelines

One-time financial assistance of up to \$100 (must be approved by an HCC pastor). Needs assessment by a financial counselor from the church. Partial assistance with short-term food needs. Financial Bible studies and debt counseling. Vocational and career testing and guidance.

However, the use of GAAP for external financial reporting purposes may be required as a contractual or legal condition for churches and other nonprofit organizations in certain circumstances. For example, a bank or other lender may require a church to apply the GAAP framework to financial statements submitted to the lender on an annual basis.

**Basic Financial Issues for the Small Church Treasurer**

The main purpose of the church audit is to conduct an independent examination of the financial statements and accounting. The accounts of the church must be checked and verified by the auditor and they can easily take out the errors in the account and they also check the credibility of the accounts and the finances.

The culmination of these tests is the formulation of an opinion on the financial statements (which should consist of at least a statement of the assets and liabilities of the church and a statement of the revenues, expenses, and net asset or fund balances of the church). The opinion is expressed in a report, which is issued to the congregation.

**Audit Program for Internal Auditors of Churches**

Paragraph 129.24 requires an annual audit of the church's financial records. This is a bit more difficult. However, an annual audit of the church's records is a must. External audits are performed by an independent auditor who has no impairing relationship to the church and, therefore, can review its data procedures with maximum objectivity.
